Pursuant to the provisions of *Philippine Fisheries Code of 1998 (RA No. 8550, as amended by RA No. 10654, An Act to Prevent, Deter and Eliminate IUU Fishing)*, *Food Safety Act 2013 (RA No. 10611)* and *Wildlife Resources Conservation and Protection Act (RA No. 9147)*, its Implementing Rules and Regulations, and *Fisheries Administrative Order No. 233, Series of 2010, the Aquatic Wildlife/Fish and Fishery/Aquatic Products*.

One vital role of the Fisheries Inspection and Quarantine Section (FIQS) is to secure all entering and exiting fish and fishery/aquatic products must be free from any pathogen and virus. This is being executed through the issuance of Local Transport Permit (LTP) with corresponding charges base on the quantity being transported by the shipper.
