Subject : **Request for a meeting with the Technical Staff of the Bureau of Agrarian Reform Services**

Dear Minister Yacob,

Assalamu Alaikum Warahmatullahi Wabarakatuhu!

This is relative to a parcel of land situated in the municipalities of Wao and Bumbaran, Province of Lanao del Sur with an area of 26,000 hectares more or less, which was the subject of the Presidential Proclamation No. 2046, series of 1981 (*please see the attached copy of the Presidential Proclamation*) mandating the Southern Philippines Development Authority (SPDA) to manage and administer.

In compliance with the mandate stipulated in the aforesaid Presidential Proclamation and by virtue of the Letter of Instruction (LOI) 1127, series of 1981, the SPDA together with other government agencies identified in the LOI has initiated the implementation of the Kapatiran Agro-Industrial Cooperative Settlement (KAICS) Project starting in the 1980s. The initial project implemented, covering about 2,000 hectares more or less consisting of farmlots and houses with identified stewards was then turned over to the defunct Autonomous Region in Muslim Mindanao (ARMM) by virtue of the Executive Order No. 142, series of 1993 for their management. The project, however, was not sustained and the subject area is under SPDA's administration.

At present, the Authority in collaboration with the Philippine Economic Zone Authority (PEZA) is pushing for the development of the proclaimed area as the center of the proposed Mindanao Special Economic Zone (MinSEZ). The MINSEZ envisions to develop an agri-industrial community by inviting private business partners to jointly develop with SPDA various agricultural crops and process them into value-added products for local and export markets with the community as the primary target beneficiaries. However, in the course of our profiling and documentation, we learned that portion of the proclaimed property, approximately 2,000 hectares more or less were accordingly placed under the coverage of the Comprehensive Agrarian Reform Program (CARP) without the participation of SPDA in the process.

Given the foregoing and being the duly designated Administrator of the property as stipulated in the aforesaid Presidential Proclamation, we wish to schedule for a technical discussion with your technical staff from the Bureau of Agrarian Reform Services on January 7, 2021 at the MAFAR-Bureau of Agrarian Services Office. As our reference during the discussion, may we respectfully request for the following documents to be available during the meeting, to wit:

- a. Legal basis of the coverage;
- b. Copy of the Certificate of Land Ownership Award (collective or individual); and
- c. Copy of the Approved Perimeter/Subdivision Plan of the area covered.

Finally, we pray that this collaboration will build a stronger alliance as we work together to protect and promote the interests and welfare of our constituents in this part of the Bangsamoro Autonomous Region in Muslim Mindanao.


