 5. Items delivered must have warranties for unit replacement, parts, labor, or other services
 6. Quoted price must be inclusive of taxes and other charges or fees and shall not exceed the ABC
 7. Failure to comply with these conditions would mean disqualification of your submitted quotation.
 8. Liquidated Damages (Sec. 68, RA 9184): All contracts executed in accordance with the Act and this IRR shall contain a provision on liquidated damages which shall be payable by the contractor in case of breach thereof. For the procurement of Goods, Infrastructure Projects, and Consulting Services, the amount of the liquidated damages shall be at least equal to one-tenth of one percent (0.001) of the cost of the unperformed portion for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
