 - 2.5.Income/Business Tax Return (For ABCs above P500K)
 - 2.6.Omnibus Sworn Statement (Omnibus Sworn Statement for ABCs above P50K)
- 3. Place the quotation in a sealed envelope and type the following details on the dace of the envelope
 - 3.1. Company's Name
 - 3.2.RFQ Number
 - 3.3.PhilGEPS Reference Number

- 4. Delivery period must be at least Thirty (30) calendar days from the reciept of the PO
- 5. Items delivered must have warranties for unit replacement, parts, labor, or other services
- 6. Quoted price must be inclusive of taxes and other charges or fees and shall not exceed the ABC
- 7. Failure to omply with these conditions would mean disqualification of your submitted quotation.
- 8. Liquidated Damages (Sec. 68, RA 9184): All contracts executed in accordance with the Act and this IRR shall contain a provision on liquidated damages which shall be payable by the contractor in case of breach thereof. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminated the contract, without prejudice to other courses of action and remedies available under the circumstances.
